## District Three Contact Guide

### A. All Emergencies – Dial 911

1. All *life threatening* situations
2. All suspected crimes in progress (examples include, but not limited to)
  - a. Prowling, Battery, Robbery, Shots Fired/Shootings, or Burglary

### B. Non Emergencies – Dial 933-4444

1. When an officer is needed at the scene but the situation is not life threatening.
  - a. Loud Music or Neighbor trouble (non-violent)
2. To speak to a *Communications Supervisor* – Dial 935-7472

### C. District Notifications – Dial 935-7233 or 935-7232 (3<sup>rd</sup> District)

1. Non-emergencies when a squad is not needed. (Examples are, but not limited to)
  - a. Vacant house (on vacation and would like squad to check home)
  - b. FAX number 935-7113 (Hot spot forms or drug complaint forms)
